### **GENERAL RELEASE**

I hereby release Producer and Producer's successors, licensees, agents, and assigns from and against any claims, demands, actions, causes of actions, suits, costs, expenses, liabilities, and damages whatsoever I may now or hereafter have against Producer or Producer's successors, licensees, agents, or assigns in connection with the Program and/or my Appearance in the Program and the preparation, production, performance, broadcast, exhibition, distribution, and/or exploitation thereof or any other use or exploitation of the rights granted to you hereunder.

I represent and warrant that I have not and will not accept from anyone, or pay to anyone, any money or other valuable consideration for the inclusion of any "plug" (i.e. product identification) in the Program.

Nothing contained herein shall in any way obligate Producer to exercise any of the rights granted hereunder or to prepare, produce, exhibit, distribute, or use the Program and/or my Appearance in the Program or to otherwise exercise any of the rights granted herein.

Producer shall have the right to assign this Agreement and any of the rights contained herein, in whole or in part, to any person, firm, corporation, or other third party.

I hereby represent and certify that I am over eighteen years of age and that I may freely and competently contract for in my own name insofar as this Release is concerned.
